Supervisors Meeting  
January 20, 2026

The Franklin Township Supervisor met on the above date at the Franklin Township Administration Building, located at 900 Fairyland Road. The following supervisors were present, Fred Kemmerer, Nic Storm, and Secretary Elizabeth Grodis. The purpose of the meeting was to review the reports of officers, as well as address the most recent business.

Fred Kemmerer called the meeting to order at 6:31pm. Nic Storm led those present in the Pledge of Allegiance to the American Flag.

Fred Kemmerer motioned the approval of minutes. Nic Storm seconded this motion. Motion carried.

Elizabeth Grodis read the Secretary's Report including the following. There will be training with instructor for G-Works garbage and sewage accounts.
